Motion by Ronspies and seconded by Acklie to approve the City Of Pierce Claims in the amount of \$145,705.94 and the Pierce Utilities Claims in the amount of \$216,176.43 for a total of \$361,882.37. Voting Aye: Ronspies, Acklie, and Bates. Nay: None. Absent: Maas. Motion carried.

Motion by Acklie and seconded by Ronspies to open the hearing on the application to the Nebraska Department Of Economic Development for a Downtown Revitalization Planning Grant in the amount of \$30,000.00. Voting Aye: Acklie, Bates, and Ronspies. Nay: None. Absent: Maas. Motion carried.

Tom Higgenbotham of the Northeast Nebraska Economic Development District explained the various aspects of the Downtown Revitalization Planning Grant application. It was noted that the City Of Pierce matching funds would be \$9,450.00 instead of \$9,000.00 that was listed in the Notice Of Public Hearing.

The application represents Phase I in which \$30,000.00 of Community Development Block Grant Funds is being requested and of that amount, \$27,000.00 would be used for planning activities and \$3,000.00 would be used for general administration of the grant. The \$9,450.00 City Of Pierce matching funds would also be used for planning activities. The total amount of planning activities is \$36,450.00 and the total project budget is \$39,450.00.

If the grant application is successful, a consultant would be hired to implement the planning activities process.

It is further declared that it meets the definitions of blighted according to the criteria set forth in Section 18-2103 (11) (a) of the Nebraska Community Development Act and at least one of the factors set forth in (i) through (iv) of Section 18-2103(11)(b) of the Nebraska Community Development Act.
